

## **SUMMARY ANNUAL REPORT**

### **For Sample Supports Welfare Benefit Plan**

This is a summary of the annual report of the Sample Supports Welfare Benefit Plan, EIN 27-1316062, Plan No. 501, for period January 01, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Aflac, American United Life Insurance Company, Humana Insurance Company and Principal Life Insurance Company to pay health, dental, vision, life insurance, HMO, PPO, indemnity and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$560,390.
